1. The meeting was called to order at 705pm. Cindy lead the members to say the Pledge of Allegiance and prayer for our men and women in the military.
2. Cindy welcomed every one and announced the speakers for the evening.
3. Salmen High School Principle Terri Wortman and St Tammany Junior High School Principle Vincent DiCarlo were first on the agenda. They each gave a report on their schools regarding the campuses and achievement scores and the good things happening in their schools. Slidell High will open this fall in the all new facilities. These include state of the art library, science labs and sports areas. They wanted to assure the residents in the area that they have a quality school for their children to attend.
4. A second set of street signs have been ordered and will complete Windward Passage to the east.
5. The June 6th drive way social was lots of fun. Free snowballs were provided by Mr. Snoball, Lee Longstreet had a copy of the recently proposed Hwy 11 project and drawing for review, and State Representative Greg Cromer and his wife Peggy attended. We will announce when the next social will be held.
6. American Flags were distributed Memorial weekend.
7. Richie Artigue, Parish Councilman, and 5 representatives from BP Company presented an update on the actions St Tammany Parish is taking to keep the oil out of Lake Borne and Lake Ponchatrain. ST Parish and BP have a command center at the Pearl River launch with boom to deploy. There is a 10:00 am meeting every morning, 7 days a week with Kevin Davis, parish officials and BP to problem solve and address issues. There are stations for boats to be decontaminated as needed. BP claims office is located at 2040 Gause Blvd. A question and answer session was opened with many residents participating. After much lively discussion, everyone agreed the #1 goal is to stop the oil leak.
8. Richie opened the floor to other issues:

- a. Parking on the green spaces and in the streets
 - b. Boat House ordinances- call code enforcement.
 - c. AT&T cable project- problems through out the parish of not completing the work and leaving it messy. It was noted the large holes on Eden Isle Drive with orange fencing. Richie will call responsible party.
 - d. Storm surge protection will not include the Shoreline area.
 - e. Recreational area for fishing and sandy beach, there are issues with leasing the green area at the end.
9. Mr. R Martin and Mr. Pat Brady of the Slidell Flotilla-Coast Guard Auxiliary located above Marina Café, spoke to the member about the Citizen Action Network(CAN). It is like the Neighborhood Watch program but designed to protect property on the waterways. The Slidell Flotilla meets the 2nd Wednesday each month at the Tammany Yacht Club. They are not law enforcement but actively participate in Search and Rescue. They presently have 8 water craft for this activity including Jet Skis, party Barge. They will be offering an 8hour boating class June 26th for \$25 to cover books and supplies. through
10. Lee Longstreet presented the most recent Hwy 11 proposal to the group. There will be a third meeting and the parish is looking for resident's feedback. Please complete a comment form so they will know your concerns. The Board asked for comments and show of hand of those in favor of the proposal. All attendances agreed and approved the Board to write a letter to the parish expressing this recommendation.
11. A concerned resident asked to speak regarding the Oxford Houses on Pebble Beach and Eden Isle Drive (www.oxfordhouse.org),. He said that 7 men live in the house and he has noted many activities during all hours with multiple outsiders coming to the house.. He has contacted Mr. Levine of the Louisiana Health and Welfare office with no resolution. As far as he can tell, there is no supervision, and multiple license noted for Texas, Mississippi, and others.
12. 50/50 cash prize worth \$20 was awarded and 4 door prizes were given away including a crayfish platter, decorative July 4th plaque, Scentsy Aroma diffuser, and a boat bag.
13. A motion was made and seconded to adjourn the meeting. The motion was passed unanimously.
