# Should Highway 11 be Widened and Beautified? *What is Your Opinion?*

An informational meeting was held on October 29, 2009 to determine public opinion on a proposed project to widen U.S. Highway 11 from Lake Pontchartrain to Spartan Dr. from two lanes to four lanes with a center median, walk ways, bike paths and landscaping. Mr. Walter Brooks the executive Director of the Regional Planning Commission (RPC) stated that the funds are available for this project, but if the residents of Slidell oppose the widening and beautification of highway 11 the funding would be used elsewhere and not on highway 11.

The audience was mostly business owners located along that part of highway 11 and they were very vocal in their opposition to the project. They believe the project would limit their use of the public right-of-way for parking and garbage dumpster storage. They also believe that there is no need to expand Highway 11 to four lanes since the bridge is only two lanes. The most they would be willing to except is two lanes with a center turning lane.

With the large number of business representatives at the meeting in opposition to the project the atmosphere was very intimidating and very few spoke out in favor of the four lane beautification project. Those in favor of the project believe the highway right-of-way belongs to all Louisiana citizens and to deny tens of thousands of citizens this vital safety and traffic improvement simply to appease a few businesses that want to maintain their private use of public right-of-way is not acceptable justification to limit the project's scope. They also believe that if an independent traffic flow studies verifies the need for four lanes in order to improve traffic flow and safety than the project scope should remain four lanes. *(article continued on page 4) (Sketch of proposal on page 5)*

## **Eden Isles Installs Security Cameras**

We are proud to say that the Eden Isles Homeowners Association has installed a system of high-resolution security cameras with digital recording capability to replace the original security cameras that were mounted on the roofs of our guardhouses destroyed by hurricane Katrina. This new system is far superior to our old system and it is capable of recording the license number, make, model and color of all vehicles entering and/or leaving the Eden Isles community. In the event of criminal activity, the data captured on the security system can provide the Sheriff's office with the necessary information needed for their investigation.

Eden Isles Homeowners Association board member, Mr. Ralph Grimaldi, proposed the re-installation of security cameras at the association's June general membership meeting and the proposal was unanimously approved. Upon receiving approval from the Homeowner's Association membership, Mr. Grimaldi solicited bids from several security companies and "Security One" won the bid competition. Since that time Mr. Grimaldi, Security One and the St. Tammany Sherriff's department have been working towards overcoming issues to install and provide a high quality security system that will provide the maximum amount of security for Eden Isles.

The installation, aiming, and tweaking of the system was more involved than originally anticipated. Originally we had hoped to install the cameras on the existing light poles, but CLECO refused access to their poles. New poles were installed next to the CLECO poles to be as inconspicuous as possible, but that location could not provide the picture quality necessary to capture license plate numbers under all conditions and they had to be moved to their current locations.

We are extremely proud of this state of the art security system that is now protecting our island paradise and it will provide a level of security equal to or greater than any gated community in the parish but without the gates. This system is not in place to issue speeding tickets or stop sign violators, but it will deter crime, assist in the return of stolen property, and assist in the apprehension of criminals. All inquiries for access to camera's recording data base must go through the Sheriff's office. The Sheriff's department has indicated they are very happy with our system and they believe it is a tremendous asset to our community.

Ms. Elizabeth Hoffmann, President of the EIHOA, sees the installation of these security cameras as a significant step towards the continuing recovery of Eden Isles from the devastating effects of hurricane Katrina. Ms. Hoffmann hopes the security cameras, along with the many beautification projects currently underway, will encourage more residents to join and support the association and thus enable the HOA to continue with the many improvements and advancements necessary to re-establish Eden Isles as The Premier Waterfront Community in Southeast Louisiana.

### **Buffalo Chicken Dip** *by Ann Nash*

1 whole rotisserie chicken or 2 lbs  
cooked, shredded/chopped chicken  
(thighs work well) 1 bottle Frank's  
Buffalo Sauce (can put more or less  
depending on how spicy you want it)  
16 oz cream cheese softened  
16 oz Ranch dressing  
8 oz Sharp cheddar cheese

It should be noted that the four lane proposals still provide anywhere from 34 feet to 54 feet of green space from the road's edge to the right-of-way property line.

As Mr. Walter Brooks the RPC stated, if we oppose the widening and beautification of highway 11, the funding will go somewhere else in the state and not here. Therefore, this will probably be our only chance to get improvements to this area. Please mail or email your comments to the project's consultant and attend the next public meeting on this issue to let your opinions be known!

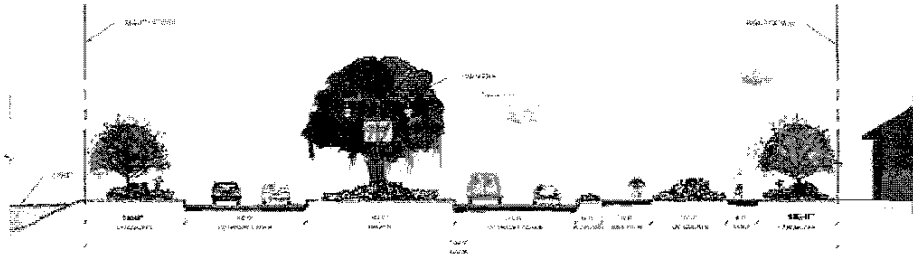

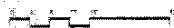
**SKETCH

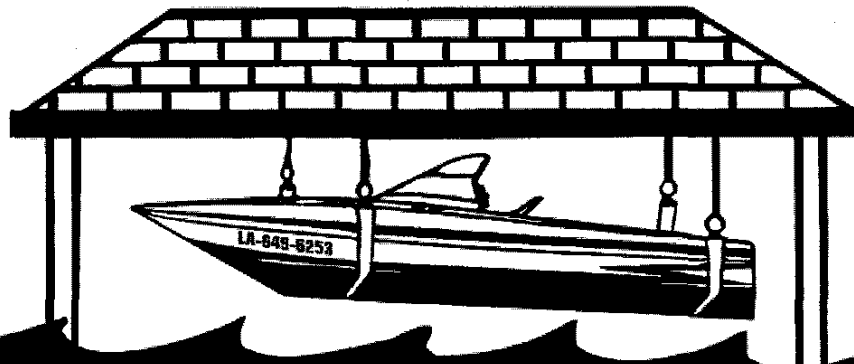

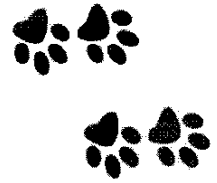

## DOTD Refuses to Reinstate Eden Isles to the I-10 Exit 261 Signs

Twenty years ago when the Eden Isles I-10 exit was constructed the Eden Isles Homeowners Association lobbied the DOTD to add the community designation of "Eden Isles" to the Exit 261 signs and the DOTD granted the request. Now that a the twin span bridge is near completion the DOTD has replaced the Exit 261 signs and removed the community designation of "Eden Isles". Once again the Eden Isles Homeowners Association contacted the DOTD and requested that the community designation of "Eden Isles" be reinstated to the Exit 261 signs.

Unfortunately, the DOTD has refused this request with the following explanation: "Rural interchanges are generally designated by guide signs that contain the intersecting route marker legend and the community name. Urban interchanges, however, are usually named after the intersecting roadway as specified by DOTD and FHWA signing standards. Since the Interstate 10 interchange at Oak Harbor is considered an urban interchange, Eden Isles would not qualify as the primary designation under current standards. The old signs with the Eden Isles legend along Interstate 10 qualified because the area was considered rural at that time." The DOTD has added supplemental guide signs that state "Northshore Harbor Center, Eden Isles, Next Exit".

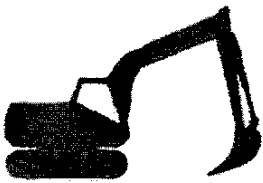
