Notice is hereby given pursuant to Article 7, Section 23(C) of the Constitution and R.S. 47:1705(B) that a public hearing of the Northshore Harbor Center District Board of Commissioners will be held at its regular meeting place, the North-shore Harbor Center at 100 Harbor Center Blvd., Slidell, Louisiana, on Tuesday, July 5 at 6:00 p.m. to consider levelng additional or increased millage rates without further voter approval or adopting the adjusted millage rates and rolling forward to rates not to exceed the prior year's maximum. The estimated amount of tax revenues to be collected in the next tax year from the increased millage is \$1,248,399.81 and the amount of increase in taxes attributable to the millage increase is \$194,497.08

Parking of vehicles on any other portion of the lot other than the garage or driveway shall be prohibited. Parking on the front lawn is strictly prohibited.

Our hurricane season officially began June 1st. Get a comprehensive plan of evacuation in the event we face severe weather this year. BE PREPARED! Check our web for Hurricane information.

Eden Isles General Membership Meeting March 15, 2011 Tammany Yacht Club

- 1. The meeting was called to order at 7:30pm. The pledge and moment of silence was observed. Cindy asked for the board members to give their reports.
- 2. Secretary- Copies of the minutes from the December meeting were available prior to the meeting. A motion was made to dispense with the reading of the minutes and acceptance of the minutes. This motion was seconded and passed unanimously.
- 3. Treasurer- Denise gave the treasurers report as of the meeting. January 1- \$14,984, income-\$29,756 and expenses- \$12,875 with a balance of \$31,875.

 There was discussion on ways to increase our membership. There are about 400 of the approximately 1200 homes who pay the dues of \$10a month each year. The newsletter will continue to have the paid members names listed. In addition, a garden flag will be given to every home of paid members.
- 4. Coastal Waste pays the EIHOA a rebate for each customer in the area for using their service. This money goes towards landscaping and beautification each quarter. Another member reminded the group of the one-month discount for paying yearly.
- 5. Green Force- Paul discussed the new grass cutting company that was recently signed, Voss and Sons. Paul asked for feedback and there was no problems discussed.
- 6. Special Projects- Lee presented an update on working with our sister neighborhoods of Lakeshore, Northshore Beach, Palm Lake, Oak Harbor and Clipper Estates. Key representatives from each neighborhood were identified to interface with our State Senator, A. G. Crowe and Representative Greg Cromer. Info will follow on results from meetings with flood protection agency representatives.
- 7. Guest Speaker_ Senator A. G. Crowe presented the proposed Breakwater project that consists of berms built off the shoreline to protect against storm surges between the twin spans to Hwy 11 Bridge. He had a diagram showing the location. Mr. Crowe also talked about the Sunrise Point Park. This will be built immediately east of the Twin Spans to access the fishing pier. It would be maintained by the parish and would have bathroom facilities and park areas. He briefly spoke about redistricting due to population shift. Mr. Crowe answered questions from the audience and gave his contact information to reach him. www.agcrowe.com or 985-788-9772.
- 8. The street signs should be completed by December 2011.
- 9. Coast Water will repair a water line Thursday in our neighborhood. All residents will need to boil water until all clear announced. Signs will be posted.
- 10. Door prizes were pulled and \$129.00 was the 50/50 amount split with home owner.

Even Better the Second Time Around

In April 2004, St. Tammany Parish announced a landscaping and improvement plan for the Oak Harbor/Interstate 10 Interchange. The landscape design work, by Kyle Associates, was submitted by the Regional Planning Commission to the Federal government for funding in Fiscal 2005. The I-10 at Oak Harbor Boulevard Landscape Beautification & Enhancement Project was awarded to St. Tammany Parish Government for \$108,023.74, with the Parish putting up the 5% match of \$5,685.46. The RPC submitted the grant application and paid for the design by Kyle Associates. Katrina delayed the planting.

Today, St. Tammany Parish is pleased to announce that work will begin with the next planting season at the Oak Harbor/Interstate 10 Interchange. "This is one more sign of rebirth and recovery," said Parish President Kevin Davis. "About one year ago, the interstate was littered with boats and debris at this location. Today, we are celebrating a public safety and beautification project. Each day brings us closer to some new sense of normalcy."

The purpose of the proposed I-10/Oak Harbor Landscape Improvements is to continue St. Tammany Parish's philosophy of incorporating the protection or re-establishment of the natural environment in all aspects of development throughout the parish. The addition of these improvements would continue that philosophy while also providing a welcome to those commuters traveling through St. Tammany Parish via Interstate 10.

"This is a critical entrance point to St. Tammany Parish," said Davis. "As visitors cross Lake Pontchartrain on Interstate 10, this is our first opportunity to make a great impression. Good impressions build tourism and business for St. Tammany."

Landscape improvements planned for the intersection include four (4) different species of Palm trees: Canary Island Date Palm, Sabal Palm, Queen Palm, and Chinese Fan Palm. The trees will be planted in mass groupings in which they will provide a significant aesthetic value to the area. St Tammany Web Release, Thursday, November 2, 2006.

Who enforces the Eden Isles covenants? <u>You do!</u>

Unlike Oak Harbor or Clipper Estates the Eden Isles Homeowners Association does not have the authority to place liens on properties that violate our covenants. Our covenants can only be enforced through legal action and any individual has the authority to bring legal action against any violator (go to eihoa.org and read the enforcement paragraph in the covenants).

Taking legal action against covenant violators is expensive and most individuals and the association does not have the funds necessary to hire a lawyer and go through the legal process required to resolve covenant disputes. Dues received by the association barely cover the cost of maintaining our park grounds and paying for a few other amenities to improve the quality of life in our community (see the associations' mission statement on eihoa.org). If everyone paid their dues then funds would be available to take legal action against violators, but that simply is not an option at this time.

What the association has attempted to do, on your behalf, is encourage the sheriff's department and the parish code department to enforce their ordinances, which parallel our covenants very closely (links to parish ordinance can be found on our website eihoa.org). Blighted homes, vehicles and boat trailers stored on public streets and on park grounds, overgrown lots, litter, etc. are all violations of parish laws and ordinances and the sheriff's department and parish code department have the responsibility, the authority and the resources to enforce these laws and ordinances.

The association board members are unpaid volunteers that unselfishly take time out of their busy schedules to help improve the quality of life for everyone living in our island paradise. The board understands and shares your frustration and they have tried very hard to get the sheriff and parish to honor their commitments, but the board is not the neighborhood police department and they have as much authority to enforce our covenants or parish ordinances as you do. Many times the sheriff or parish code department will be more responsive if an individual calls rather than a board member.

So rather than call a board member to complain about a neighbor's dog defecating on your lawn or a blighted house or overgrown lot or a boat or motor home stored on the street why don't you first try to resolve the issue with your neighbor. If that doesn't work then call the public agency that takes your taxes and is responsible for enforcement and has the resources and authority to correct the problem (you can find their phone numbers in the newsletter or on the website).

Thank you for your understanding and cooperation. Together we can work towards waterfront living at its best.






What garbage service should I use?

Eden Isles is unincorporated and therefore falls outside of the Slidell municipality jurisdiction. Residents living in unincorporated areas of St. Tammany (such as Eden Isles) are allowed to choose their own garbage service.

Originally Waste Management was the only garbage company servicing Eden Isles, then in 2003 Coastal Waste Services (also known as IESI) began offering garbage service. As an incentive to increase their client list, Coastal Waste Services agreed to contribute "Beautification" money to Eden Isles Greenforce (committee that oversees the maintenance of our entrances and greenspaces. The amount they contribute each quarter depends on the number of homes they service.

The Homeowners Association endorses Coastal Waste Services and request you use their service for three reasons: 1. Coastal Waste Services provides rebates to help maintain our park grounds. 2. Reducing the number of garbage collectors in Eden Isles will help maintain our streets. 3. Their rates are competitive.

You may have seen new garbage cans in the neighborhood with IESI on them. This is Coastal Waste new logo. If you are not already a Coastal Waste customer please consider changing to them; Coastal Waste Services (IESI) may be reached at 985-781-3171



YOUR HOMEOWNER'S DUES AT WORK

We're nearly five months into the 2011 budget. Since some of our homeowners are unable to attend the general membership meetings (where we give a YTD banking summary) we thought it would be a good idea to include in this newsletter, a brief summary of our year to date income and spending.

The Eden Isles Homeowners Association income for this year has reached \$52,614.00, and our expenses for the year to date has been \$24,150.68

Income:

\$50,095.00 from dues

- \$ 2,388.00 from the Coastal Waste contribution, for community beautification
- \$ 131.00 from our 50/50 raffle at the general membership meetings.

Expenses:

\$10,170.00 Street signs and entrance repairs

- \$ 7,230.00 Green-space / park grounds maintenance and upkeep (Grass cutting, etc.)
- \$ 2,500.00 Membership flags
- \$ 1,381.00 News letter printing and delivery
- \$ 900.00 Security Cameras
- \$ 869.00 Holliday decorations (Decorations have been saved for future use)
- \$ 360.00 Returned to members for overpayment of dues.
- \$ 205.00 Utilities
- \$ 165.00 Mini storage rental
- \$ 370.00 Misc.

Currently we have a bank balance of \$28,463.00. As of the end of May, 412 homeowners paid their 2011 dues. A potential additional income of approximately \$7,000 from the Coastal Waste rebate will increase the balance to approximately \$35,000 for the rest of our 2011 budget.

Our expenses for the balance of the year include \$18,845, contracted for grass cutting, leaving us with a \$16,000 budget for the balance of the year to cover other items like insurance and meetings.

Realistically, our Homeowner's dues of \$120 per year (only \$10.00 per month) is all that we can count on for maintaining and supporting the neighborhood. Although dues paying homeowners have steadily increased every year following Katrina, more funding would allow the association to accomplish more.

A note about dues:

The parish does not maintain or fund the maintenance of the public spaces of our neighborhood, your homeowners association does!

Monies collected are used for cutting the grass in all of the public green spaces through out the neighborhood. Lighting, maintaining and seasonal decorations of the signage. Installation & maintenance of the street signs. Cost, repair and utilities associated with the security cameras. Planting & maintaining the landscaping. Publications, posters, newsletters, postal service & postage. State fees regarding the entity of the association. Water testing Lab expenses. Expenses of holding meetings. Insurance & Legal.

Note: Board & committee members are uncompensated neighborhood volunteers whose only interest is contributing to the well being of the neighborhood as their time permits.

Those not contributing to the upkeep of the neighborhood (paying of dues) create an undue burden in trying to implement all the association is charged with doing. The more homeowners that participate, the more your association can accomplish. The current level of financial participation does not leave our budget with the funds necessary for the expensive legal process of enforcing the covenants they way they should. Although the covenants are a legally binding part of your deed, without sufficient association funding, the burden of enforcement rest with each individual homeowner. Fortunately, most of the covenants have mirror parish laws which you can request the parish enforce. These are notated on the EIHOA "guide to the covenants" listed on our website.

Although Katrina "whacked" us all, your homeowners association is making a comeback, just check its website at www.eihoa.org to see all that is going on.
